## 7. Report on the ongoing virtual Congress 2021

Birger Kollmeier made a short report on the ongoing virtual Congress 2021. The concept of the completely virtual congress was six condensed focus sessions with invited speakers and 18 free contributions. So far, 402 participants are registered.

# 8. Report on progress for Croatia Congress 2023 and future congresses (Austria 2025)

A short report and update on the plans for the EFAS 2023 congress in Sibenik, Croatia as well as the EFAS 2025 congress in Vienna, Austria was given.

#### 9. EFAS awards

The 2021 EFAS life-time award was given to Prof. Jan Wouters from Leuven, Belgium, for his contributions and commitment to clinical and experimental audiology. Jan Wouters have previously served as general secretary of EFAS. The laudation on behalf of Jan Wouters was given by Prof. Wouter Dreschler, Amsterdam.

### 10. Election of new EFAS board (period 2021-2023)

Two candidates were proposed for the post as Vice chairperson, Madalina Gerorgescu from Romania and Robert Trotic from Croatia. The outcome was that Robert Trotic was elected as Vice Chairperson.

The others who were elected for the board were re-elections of Stefan Stenfelt (Sweden) as Secretary-General and Dorothe Veraguth (Switzerland) as Treasurer.

The two Auditors, Vinay Nagaraj (Norway and Piotr Skarzynski (Poland) were also re-elected.
